#### OREGON BOARD OF DENTISTRY GENERAL INFORMATION AND ...

At it s August 21, 2020, meeting the Board voted to implement the proposed temporary licensure rules requiring that the clinical licensure examinations include at a minimum a clinical portion demonstrating psychomotor competency utilizing a typodont mounted in a manikin or live patient (proposed changes to OARs). The temporary rule changes would go into effect January 31, 2021.
